Increase attic insulation to at least R60 from R35 or less	\$750	Minimum 20% insulation required
Increase cathedral/flat roof insulation by at least R14	\$650	
Exterior Wall Insulation - Prorated based on % completed		
Add at least R20 to 100% of building	\$3,000	Minimum 20% insulation required
Add at least R9 to 100% of building to achieve a minimum of R12 (solid masonry walls do not need to achieve R12)	\$1,750	
Add at least R3.8 to 100% of building to achieve a minimum of R12 (solid masonry walls do not need to achieve R12)	\$1,000	
Foundation Wall Insulation- Prorated based on % completed and if more than one foundation exists		
Add at least R23 to 100% of basement	\$1,250	* Bonus \$500 if the remainder of existing insulation is completed to 100%. This applies to basement exterior wall, crawlspace exterior wall or a combination of both.
Add at least R12 to 100% of basement	\$750	NOTE: Minimum 20% required when insulating a basement however 5% minimum insulation requirement instead of 20% if the remainder of the existing insulation is completed to 100%.
Add at least R23 to 100% of crawl space wall	\$1,000	
Add at least R12 to 100% of crawl space wall	\$500	
Add at least R32 to 100% of floor above crawl space	\$1,000

Install Energy Star 0.8 EF (tank) or .9 EF (tankless)	\$400

For replacing a less than 95.9% AFUE natural gas furnace with a 96% AFUE or higher condensing natural gas furnace	\$250	Requires 2 additional upgrades
For replacing a less than 90% AFUE natural gas boiler with a 90% AFUE or higher condensing natural gas boiler.	\$1,000	Requires 1 additional upgrade

Install ENERGY STAR® qualified window, door or skylight	\$40	Per rough opening

Target + 10%	\$150	Must achieve 10% higher than target
